#### Old Business:

Lawn Pesticide/Fertilizer Treatment- This was discussed and will be incorporated into the 2026 budget to continue to have the recommended treatment done.

Termite Contract-Discussed when Haskell will come out to do the annual inspection. Discussed the bait traps and if the board wants to move forward with a recommended termite preventative treatment. This was included in the 2026 Budget.

Water Shut Off Valves- Waiting on estimates from plumbing companies.

Roof Maintenance- Watertight Roofing will come out in November to do an annual inspection.
